Are you a church leader in need of financial assistance or advice on church real estate? Do you need help with overwhelming building challenges?



Every year since 2009, the **United Church of Christ Church Building & Loan Fund (CB&LF)** has convened

at least one **Partners in Building (PIB)** training event in different regions around the country. This year's event will be held on **Friday September 22 to Saturday, September 23, 2017 in Cleveland, Ohio**. The registration cost to PIB participants is only **\$100 per person**. CB&LF pays for housing, meals and travel expenses for up to three church leaders. Church leaders that register for PIB will be asked to complete a short questionnaire that will be reviewed by CB&LF staff to determine that **PIB** will benefit their congregation.

For the second year in a row CB&LF is offering the opportunity for **PIB** participants to **attend one of five workshops that will be offered BEFORE the regular PIB program begins**. The registration fee for each **Pre-PIB seminar** is an additional **\$70 per person and includes lunch**. Interested registrants may choose **ONE of the five pre-PIB seminars offered at 11:45 am on Friday afternoon, September 23rd**:

The Future of Stewardship: Partnering to Build a More Vibrant Church -Learn about the United Church of Christ's new program to help churches strengthen finances and increase giving.

Partners in Vision: Taking on Large or Complex Church Building Projects -Learn how CB&LF assists churches and church organizations with large and/or complex building projects.

Living Legacy – Learn about the UCC resource designed to assist churches entering into the final phase of their organizational and missional lives.

It Begins with Mission & Vision – Articulating your congregation's "why" is the most important first step in any church building project. This workshop will help church leaders to begin to discern their distinctive mission and vision.

Bricks to Mission: Repurposing Church Property – Ways that churches may approach new uses for older church properties.
