Email Safety and Spam Messages from PSEC

Thank you to those who reached out to let us know about spam messages that were recently sent, purporting to be on behalf of Conference Minister Rev. Bill Worley. We are working with our tech company to help reduce the number of these emails that are sent. We want to use this as a reminder for how to spot misleading emails. Keep in mind that emails are suspicious if:

they ask for something of monetary value (gift cards, cash transfers, etc.)

the email address is unfamiliar (even if the signature/name is familiar) always look at the return email address, not just the name

the person insists on only email communication ("don't call me")

the email address the message appears to have come from is not the one it replies to

Finally, if in doubt please call us and check prior to taking any action the email requests! Unfortunately it is important to remember to BE VIGILANT!!!
