

Summary of September 20, 2024 meeting

"Let us run with perseverance the race that is set before us, looking to Jesus, the pioneer and perfecter of faith..." (Hebrews 12:1b-2a)

Meeting on September 20, the Keystone Working Group remains inspired in our journey forward toward a vote for a Keystone Conference. "Together We Are Stronger" energizes and unites our focus. Townhall conversations have begun and have been well received with questions still being addressed. Transitional staffing questions and timeline process have opened more conversation. The subgroups all reported updates, with significant notes shared below:

Staffing

Choosing Transitional Staff for the implementation of the work of the Keystone Conference begins with the search to contract a Transitional Executive Conference Minister and Transitional Regional Conference Ministers. All transitional staff will be eligible to apply for the settled/hired positions. As the process moves forward, there will be opportunities to adjust the current model if necessary. Chairs of Personnel Committees from all 4 conferences have begun meeting and are reviewing Conference Minister position descriptions.

Governance

If merger is approved, there is a transitional board plan in process to be included in the new Constitution and Bylaws. Additionally, the Keystone Constitution and Bylaws will need to be affirmed by the 2025 Spring Meetings of each conference.

Finance

The 2026 Exploratory Budget (which includes a \$63K surplus) was presented in the first round of Town Halls and is posted with all other Keystone related documents at www.psec.org/keystone. Generosity is the key to everything we and the Spirit will accomplish together!

Associations

Association presidents across all 4 conferences have begun to meet and discuss possibilities for strengthening their leadership.

Mission

Following consensus around developing a initial unifying Keystone Conference Mission, a new subgroup created a working draft of "People of the Table." This would be in addition to, and not to replace, the mission work currently happening across all four Conferences, all of which would continue and expand across the state. The proposed mission focuses efforts already in place in all four conferences around hunger ministries and how we can work together around food insecurity for so many.
